
News from your Education Committee... Your NEW Education Chair...

IMPORTANT UPDATES from your PDC Chair...

Did you know...

- Your Professional Development Chair is responsible for processing requests for certification/designation for members of your chapter and working with your Education Chair to ensure the online and classroom courses are promoted to credentialing program candidates to ensure that they meet the requirements to obtain their certifications / designations.
- RWA certifications do not expire.
- All other certifications / designations expire every five (5) years.
- Recertification credits are provided to SR/WA designees for attending IRWA's International Education Conference.
- To obtain recertification credits for non-IRWA programs, you
 must receive prior approval from the Credentialing Committee.
 You must complete and submit the Request Form for Award of
 Recertification Credit for Non-IRWA Course.
- PLEASE ENSURE THAT YOU RECEIVE YOUR RECERTIFICATION CREDITS FOR YOUR LOCAL EDUCATION SEMINARS BY RECEIVING THE PROPER FORM FROM YOUR CHAPTER EXECUTIVES AT THE SEMINAR. YOU MUST SIGN IN AT THE DESIGNATED TIME.
- Recertification credits will only be permitted by providing your attendance certificates or proof of attendance with your Recertification Application.

SR/WA Recertification Requirements:

- 72 CEU's from courses or seminars approved for credit by the Credentialing Committee
 - Minimum of 16 credit units of IRWA courses earned in classroom or online
 - o 8 credits units of IRWA Ethics course
 - Remaining 48 credit units may be earned through IRWA courses, conferences and seminars or in combination with up to 24 credit units from outside education vendors.
