



## **ENVIRONMENTAL PROJECT MANAGER** *(Two Contractual Roles up to 18 months)*

**Metrolinx** is an agency of the Government of Ontario and our goal is to create a transportation network that enhances the prosperity, sustainability and quality of life for the Greater Toronto and Hamilton Area. We lead planning in the region with a Regional Transportation Plan that guides the work and investments of the organization. This includes building light transit, bus rapid transit and Regional Express Rail, as well as operating GO Transit, UP Express and PRESTO.

The Capital Projects Group, Environmental Programs and Assessment Division is seeking to fill two positions as Environmental Project Managers to supervise the efficient delivery of projects and programs including Environmental Assessments and related program areas of study (noise, vibration, air quality, natural heritage, cultural heritage and archaeology), Technical Advisor oversight, permits and approvals, and Environmental Mitigation and Monitoring oversight.

### **Key Responsibilities:**

- Overseeing environmental assessments and addendums carried out through Ontario Regulation 231/08 TPAP process and GO Transit Class EA, including the associated technical studies on social and physical environments (e.g. noise, vibration, air quality, built heritage, natural heritage, archaeology, design, and mitigation).
- Oversight to coordinate EA design implementation, guidance on permits and approval, and compliance monitoring programs.
- Generating consultant Terms of Reference and supervising consultant contracts engaged in environmental compliance related assignments (includes scope, schedule and budget oversight).
- Overseeing Project Coordinator level staff with respect to Program and Project execution.
- Providing advice and guidance to internal stakeholders on permits, approval and compliance related topics.
- Working with various external stakeholders including regulators and the public including but not limited to Ministry of Natural Resources and Forestry, Ministry of Environment and Climate Change, Ministry of Tourism Culture and Sport and Conservation Authorities.
- Providing an internal knowledge base of legislated environmental standards, regulations, guidelines and best practices and determining potential impacts to Metrolinx programs and assessments.

- A university degree in a related discipline (Planning/Environmental Management/Environmental Science) or any combination of education, training and experience deemed equivalent.
- Minimum eight (8) years' experience related to environmental assessment, transit/transportation planning, environmental impact assessment, stakeholder consultation and environmental compliance monitoring.
- Demonstrated experience with the Ontario and Canadian Environmental Assessment process, including Transit Project Assessment Process and Class Environmental Assessments (GO Transit, MTO, MCEA,).
- Working knowledge of the principles and practices of environmental assessment and project management.
- Thorough knowledge of the Ontario Environmental Assessment Act, Environmental Protection Act, Planning Act, Endangered Species Act, Migratory Bird Convention Act, Navigation Protection Act, and other related environmental legislation.
- Experience with planning of transit facilities for light rail and heavy rail infrastructure, including within a P3 environment.

- Experience with the coordination of a number of complex projects under pressure to meet schedule and budget commitments.
